**ORDER NO. D4/38909/11/DPI                      DATED 28.12.2011**

In the GO read as first paper above, Govt have issued orders unifying the date of retirement of Govt. employees and teachers as 31<sup>st</sup> of March every year or till the end of the academic year for teachers having different date of closing of academic year. In the circular read as second paper above instructions have been issued for filling up of vacancies, that would have arisen but for unification of the date of retirement, by creating supernumerary posts at the relevant entry level. Delegation of powers for creation of supernumerary posts is also accorded as a special dispensation for this limited purpose.

Accordingly, each Head of the Department have to assess retirement vacancies office wise, category wise and quarter wise and identify the entry cadre and create corresponding respective entry level supernumerary posts following the formalities and report to the KPSC for advice of candidates.

In exercise of the powers, supernumerary posts as detailed in column 5 in the table below is created for the period upto 29.02.2012 in continuation of this office order read as 3<sup>rd</sup> above against the vacancies due to the retirement of gazetted officers in the department.
